- 1. Conclusion of Contract : The Order is the acceptance of the Offer made by the supplier and hence, right to withdraw the offer does not subsist from the date of the order
- Mode of submission : The offers shall be submitted in sealed cover or emailed to telktenders@gmail.com in the case of offline/manual tenders. The bidder shall submit the offers well in advance before the prescribed date and time.
- 3. The offers shall be submitted in single cover system or two cover system as specified. For two cover system, Technical Bid and Price Bid are separate. First cover shall contain Technical Bid which shall contain Technical particulars, Un-priced commercial bid, Test Reports, Catalogue, and Quality Assurance Plan as applicable. Second cover shall contain Price Bid ie, BOQ (In the format if given by TELK). You shall submit all the documents of the tender duly signed & stamped as a sign of acceptance. Deviations / comment or any additional information if any, shall be furnished along with the technical bid.
